Attachment B

Propose amendments to the constitution Article 4 Section 2

Cumbria Soaring Club relies on the protection provided by BHPA insurance to safeguard members, officers, coaches, and the public from any claim arising from the lawful pursuance of our sport. BHPA membership is an essential requirement for all members of the club. It the responsibility of each member to ensure that they do not allow their BHPA membership to lapse.

The committee proposes that Section 2 be amended to clarify that club membership will terminate automatically on the date of expiry of a members BHPA membership, should that member fail to renew their BHPA membership.

The proposed amendment to the first sentence of Article 4 - Section 2 is highlighted below in red.

Section 2 - All Full, Honorary and Training members must be members of the BHPA. Club Membership will terminate automatically and without notification if/when BHPA membership expires. Terminated members wishing to rejoin the Club must re-apply for Club membership.
